Summaries of General Laws Passed at the 2001 Special Session "B" of the Florida Legislature

- **Ch. 2001-349 (S.B. 48-B)** Provides for economic assistance to publicly owned public-use airports to facilitate compliance with enhanced federal security requirements or address certain related economic impacts. Provides for noise mitigation for certain airports. Effective November 16, 2001.
- **Ch. 2001-350 (C.S. for S.B. 24-B)** Provides for inclusion of right-of-way services as part of design-build contracts and expansion of the list of transportation projects that may be awarded as design-build contracts for a specified time period. Effective November 28, 2001.
- **Ch. 2001-351 (S.B. 6-B)** Revises specified provisions to eliminate restrictions on the use of funds deposited into the General Inspection Trust Fund of the Department of Agriculture and Consumer Services. Effective January 1, 2002.
- Ch. 2001-352 (S.B. 40-B) Authorizes the Governor and Cabinet to approve administrative leave for state employees participating in disaster relief with the American Red Cross in disasters outside Florida. Effective November 30, 2001.
- **Ch. 2001-353 (C.S. for S.B. 42-B)** Revises provisions relating to continuation of health care coverage for members of the National Guard or military reserves called to active military duty. Effective November 30, 2001.
- **Ch. 2001-354 (S.B. 54-B)** Revises a provision relating to a surcharge on certain parking facilities by municipalities in a state of financial emergency. Effective November 30, 2001.
- **Ch. 2001-355 (S.B. 94-B)** Provides for the issuance of American Red Cross and United We Stand license plates and collection and distribution of annual use fees. Effective July 1, 2002.

Summaries of General Laws Passed at the 2001 Special Session "C" of the Florida Legislature

- **Ch. 2001-356 (S.B. 6-C)** Defines terrorism and provides for pretrial detention for persons charged with acts of terrorism. Effective December 10, 2001.
- **Ch. 2001-357 (S.B. 8-C)** Provides for reclassification of offenses when committed to further an act of terrorism; includes any felony that is in furtherance of an act of terrorism

- as a qualifying offense under the felony murder provisions; defines terrorism. Effective December 10, 2001.
- **Ch. 2001-358 (C.S. for S.B. 10-C)** Revises provisions relating to poisoning water systems, food, drink, or medicine under certain circumstances. Effective December 10, 2001.
- **Ch. 2001-359 (S.B. 12-C)** Permits authorization of interception of communications relating to the investigation of aircraft piracy; adds solicitation of specified offenses to the list of crimes for which interception of communications may be authorized; permits continued interception of communications in investigation of offenses relating to acts of terrorism; provides for future expiration of provisions. Effective December 10, 2001, except as otherwise provided.
- **Ch. 2001-360 (C.S. for S.B. 14-C)** Authorizes rulemaking concerning aerial application of pesticides and storage of pesticides, aircraft used for aerial application of fertilizers and storage of fertilizers, and aerial application of seed; provides for reports. Effective December 10, 2001.
- **Ch. 2001-361 (C.S. for S.B. 16-C)** Provides exemptions from public records and meetings requirements for certain security system plans or portions thereof; provides for future review and repeal. Effective December 10, 2001.
- **Ch. 2001-362 (C.S. for S.B. 18-C)** Provides an exemption from public records and meetings requirements for portions of a comprehensive emergency management plan that address the response of a public or private hospital to an act of terrorism; provides for future review and repeal. Effective December 10, 2001.
- Ch. 2001-363 (C.S. for S.B. 20-C) Provides an exemption from public requirements for specified information relating to certain facilities established, regulated, or maintained by the Department of Health as a part of the state's plan to defend against an act of terrorism; provides for future review and repeal. Effective December 10, 2001.
- **Ch. 2001-364 (C.S. for S.B. 22-C)** Provides an exemption from public records requirements for information concerning public records requests made by a law enforcement agency to another public entity; provides for future repeal and review. Effective December 10, 2001.

- Ch. 2001-365 (S.B. 24-C) Creates and revises provisions relating to counterterrorism efforts and responses to acts of terrorism; provides for establishment of regional domestic security task forces. Effective December 10, 2001.
- **Ch. 2001-366 (S.B. 26-C)** Creates the Florida Domestic Security and Counter-Terrorism Intelligence Center and the Florida Domestic Security and Counter-Terrorism Database. Effective December 10, 2001.
- **Ch. 2001-367 (C.S. for S.B. 2-C)** Provides appropriations and reductions in appropriations from specified funds for the 2001-2002 fiscal year. Effective December 13, 2001.
- **Ch. 2001-368 (S.B. 30-C)** Prescribes the salary rate for members of the Senate and House of Representatives; provides for expiration. Effective December 17, 2001.
- **Ch. 2001-369 (S.B. 32-C)** Specifies the source of the county portion of vessel registration fees; provides for remission of specified fees into the Save the Manatee Trust Fund; clarifies the appropriation and distribution of certain funds. Effective December 17, 2001.
- **Ch. 2001-370 (S.B. 34-C)** Makes funding of the pilot program for attorneys ad litem for dependent children dependant upon specific appropriation of funds. Effective December 17, 2001.
- **Ch. 2001-371 (S.B. 44-C)** Delays the increase in exemptions under the tax on intangible property for a specified time period; provides for the adoption of certain emergency rules. Effective December 17, 2001.
- **Ch. 2001-372 (S.B. 52-C)** Delays the amendment, repeal, and transfer of certain provisions relating to the Florida Building Code; provides for rule adoption. Effective December 17, 2001.
- **Ch. 2001-373 (S.B. 64-C)** Ratifies certain actions taken by local governments relating to determination of financial emergency. Effective December 17, 2001.
- **Ch. 2001-374 (H.B. 13-C)** Enacts the K-20 Funds Flexibility Act; creates, amends, and repeals provisions relating to education funding; provides for expiration. Effective December 17, 2001.

- **Ch. 2001-375 (H.B. 25-C)** Reenacts specified provisions to implement the transfer of funds from certain trust funds to the Working Capital Fund. Effective December 17, 2001.
- **Ch. 2001-376 (H.B. 27-C)** Revises provisions relating to withdrawals from the Budget Stabilization Fund to offset a projected deficit in the General Revenue Fund. Effective December 17, 2001.
- **Ch. 2001-377 (H.B. 29-C)** Revises and repeals provisions relating to the Agency for Health Care Administration. Effective January 1, 2002, except as otherwise provided.
- **Ch. 2001-378 (H.B. 65-C)** Requires adoption of an allocation and disbursement plan for certain funds appropriated from the County Article V Trust Fund; permits use of funds for the operation of trial courts. Effective December 17, 2001.
- **Ch. 2001-379 (H.B. 69-C)** Increases the amount that may be withdrawn from an inmate's individual account in the Inmate Welfare Trust Fund; creates a Prison Per-Diem Workgroup; provides for membership and duties. Effective December 17, 2001.
- **Ch. 2001-380 (C.S. for S.B. 4-C)** Provides implementing and administering provisions for the 2001-2002 Supplemental Appropriations Act. Provides specified directives and mandates certain adjustments and limitations. Effective December 22, 2001.

Summaries of General Laws Passed at the 2002 Regular Session of the Florida Legislature

- **Ch. 2002-1 (S.B. 1336)** Amends, reenacts, or repeals various provisions in the *Florida Statutes* to replace incorrect cross-references, delete obsolete or expired provisions, correct grammatical or typographical errors, remove inconsistencies and redundancies, and otherwise improve the clarity of the statutes. Effective May 21, 2002.
- **Ch. 2002-2 (S.B. 1338)** Repeals numerous provisions of the *Florida Statutes* which were repealed other than by a "current session" of the Legislature, for the purpose of omitting such provisions from publication in the *Florida Statutes 2002*. Effective May 21, 2002.
- **Ch. 2002-3 (S.B. 1340)** Repeals a public records exemption for specified records held by the Office of Tourism, Trade, and Economic Development; Enterprise Florida,

- Inc.; or county or municipal governmental entities and their employees, which expired pursuant to the Open Government Sunset Review Act of 1995. Effective May 21, 2002.
- **Ch. 2002-4 (S.B. 1342)** Removes gender-specific references to human beings from the *Florida Statutes* without substantive change in legal effect. Effective May 21, 2002.
- **Ch. 2002-5 (H.B. 275)** Revises and readopts an exemption from public records requirements for certain records held by deepwater ports. Effective October 1, 2002.
- **Ch. 2002-6 (H.B. 561)** Permits certain advanced registered nurse practitioners and physician assistants to provide the certification for disability required for the issuance of a disabled parking permit. Effective July 1, 2002.
- **Ch. 2002-7 (C.S. for H.B. 417)** Permits certain students under 21 years of age to be served and to taste alcoholic beverages as part of a required curriculum at accredited institutions in certain circumstances. Effective July 1, 2002.
- Ch. 2002-8 (H.B. 173) Revises a provision relating to computation of the documents tax on title certificates issued after judicial sale of real property and notations on certain recorded documents. Effective March 14, 2002.
- **Ch. 2002-9 (C.S. for H.B. 499)** Permits specified real estate licensees to meet continuing education requirements through distance learning courses. Effective July 1, 2002.
- **Ch. 2002-10 (H.B. 1283)** Redesignates Children's Day as Parents' and Children's Day and changes the day for the celebration. Effective July 1, 2002.
- **Ch. 2002-11 (C.S. for S.B. 1926)** Revises provisions relating to citrus canker eradication. Effective March 18, 2002, except as otherwise provided.
- **Ch. 2002-12 (H.B. 1993)** Divides the state into 25 consecutively numbered, single-member congressional districts; conforms specified provisions; provides that the federal decennial census of 2000 is the official census of the state for purposes of congressional redistricting; revises provisions relating to inclusion of contiguous and noncontiguous territory and severability. Effective January 3, 2003, except as otherwise provided.
- **Ch. 2002-13 (C.S. for H.B. 715)** Creates or revises provisions relating to outdoor advertising signs and transportation facilities. Effective July 1, 2002.

- **Ch. 2002-14 (S.B. 264)** Revises requirements for drug testing under the drug-free workplace program and requires certain state contractors to have implemented drug-free workplace programs. Effective October 1, 2002.
- **Ch. 2002-15 (C.S. for S.B. 574)** Mandates inclusion of certain springs on water management districts' priority lists and schedules to establish minimum flows and levels; provides exceptions. Effective April 11, 2002.
- **Ch. 2002-16 (S.B. 592)** Enacts the Interstate Compact on Adoption and Medical Assistance; prohibits expansion of the state's financial commitment. Effective July 1, 2002.
- **Ch. 2002-17 (C.S. for S.B. 618)** Creates, revises, or repeals provisions relating to elections issues, including voter registration, ballots, certain reports, candidate qualifying requirements, contributions and expenses, and recounts. Effective April 11, 2002, except as otherwise provided.
- **Ch. 2002-18 (C.S. for C.S. for S.B. 1360)** Creates or revises provisions relating to property tax administration. Effective January 1, 2003.
- **Ch. 2002-19 (C.S. for H.B. 245)** Creates or revises provisions relating to independent living transition services for children in foster care. Effective October 1, 2002.
- **Ch. 2002-20 (C.S. for H.B. 261)** Creates, revises, or repeals provisions relating to transportation; subjects covered include, but are not limited to, the Florida Turnpike Enterprise, high-speed rail transportation, electric personal assistive mobility devices, unlawful conveyance of fuel, and Internet availability of motor vehicle title transactions. Effective July 1, 2002, except as otherwise provided.
- **Ch. 2002-21 (C.S. for H.B. 1407)** Enacts, amends, transfers, or repeals provisions relating to the Capitol Police and the security of public buildings. Effective April 11, 2002, except as otherwise provided.
- Ch. 2002-22 (C.S. for C.S. for H.B. 1825) Transfers the Division of Vocational Rehabilitation and the Division of Blind Services from the Department of Labor and Employment Security to the Department of Education; conforms specified provisions. Creates and revises provisions relating to services for persons with disabilities; repeals provisions relating to occupational access and opportunity and certain contracts for vocational assessments and work evaluations. Effective April 11, 2002.

- **Ch. 2002-23 (S.B. 266)** Clarifies provisions relating to solid-waste collections and exempts solid-waste or recovered-materials collection vehicles from certain unattended motor vehicle prohibitions. Effective July 1, 2002.
- **Ch. 2002-24 (S.B. 332)** Revises or repeals provisions relating to athlete agents. Effective July 1, 2002.
- Ch. 2002-25 (C.S. for C.S. for S.B. 432) Creates, revises, or repeals numerous provisions relating to insurance regulation. Effective July 1, 2002.
- **Ch. 2002-26 (C.S. for S.B. 462)** Provides a maximum amount for the excise tax payable on unsecured obligations; revises an exemption from an equalizing excise tax on products made in whole or part from certain citrus fruit. Effective July 1, 2002.
- Ch. 2002-27 (C.S. for C.S. for S.B. 694) Revises numerous provisions relating to mobile home parks and condominiums. Effective July 1, 2002.
- **Ch. 2002-28 (C.S. for S.B. 998)** Prohibits making false reports of the planting of a weapon of mass destruction; revises provisions relating to planting a false bomb. Effective July 1, 2002.
- **Ch. 2002-29 (C.S. for S.B. 1058)** Provides for distribution of certain insurance premium taxes for firefighter pensions in counties with certain consolidated governments. Effective April 16, 2002.
- **Ch. 2002-30 (S.B. 1222)** Provides an exemption from public records requirements for information identifying parent(s) who leave newborn infants at emergency medical services stations. Effective April 16, 2002.
- **Ch. 2002-31 (S.B. 1568)** Creates or revises provisions relating to capital collateral representation. Effective July 1, 2002.
- Ch. 2002-32 (S.B. 1636) Redefines the term "prisoner" for purposes of the state corrections code. Effective July 1, 2002.
- **Ch. 2002-33 (S.B. 1832)** Defines the term "powered shopping cart" and provides that such cart provided and used under certain conditions is not a dangerous instrumentality. Effective April 16, 2002.

- **Ch. 2002-34 (S.B. 1914)** Permits the award of Florida Public Student Assistance Grants to part-time degree-seeking students. Effective April 16, 2002.
- **Ch. 2002-35 (C.S. for S.B. 2048)** Permits Medicaid reimbursement for adult lung transplants; exempts counties from Medicaid contributions for such transplants. Effective July 1, 2002.
- **Ch. 2002-36 (S.B. 2158)** Provides for habeas corpus petitions by persons involuntarily committed as sexually violent offenders; provides civil immunity for the Department of Legal Affairs and its employees for good faith conduct under specified provisions. Effective July 1, 2002.
- **Ch. 2002-37 (C.S. for S.B. 2178)** Provides for permanent qualification for funding emergency medical services through certain special assessments; ratifies certain special assessments. Effective April 16, 2002.
- **Ch. 2002-38 (H.B. 161)** Revises eligibility guidelines of the Relative Caregiver Program; specifies that participant children are eligible for participation in the school readiness program; exempts certain students from payment of specified fees. Effective July 1, 2002.
- **Ch. 2002-39 (H.B. 281)** Revises and readopts an exemption from public records requirements and public meeting requirements for certain reports, plans, events, and hearings relating to risk-based capital held by the Department of Insurance. Effective October 1, 2002.
- **Ch. 2002-40 (H.B. 285)** Revises and readopts an exemption from public records requirements for certain information relating to a victim or witness who has been identified or certified for protective or relocation services; provides an exception. Effective October 1, 2002.
- **Ch. 2002-41 (C.S. for H.B. 489)** Revises provisions relating to the regulation of land surveying and mapping. Effective July 1, 2002.
- **Ch. 2002-42 (H.B. 585)** Creates the Florida Uniform Principal and Income Act; defines specified terms; prescribes fiduciary and trustee duties; provides for uniformity of application and construction. Repeals provisions relating to principal and income of trusts. Effective January 1, 2003.

- **Ch. 2002-43 (H.B. 727)** Revises the process for coordination and approval of disaster-preparedness plans; enumerates plan guidelines. Effective April 16, 2002.
- **Ch. 2002-44 (C.S. for H.B. 795)** Specifies conditions for the determination of the existence of a surviving spouse under certain circumstances for purposes of recovery for wrongful death. Effective April 16, 2002.
- **Ch. 2002-45 (H.B. 935)** Provides a public records exemption for personal identifying information for participants in the Public Employee Optional Retirement Program. Provides for future review and repeal. Effective April 16, 2002.
- **Ch. 2002-46 (C.S. for H.B. 1085)** Enacts, reenacts, amends, or transfers provisions relating to the Fish and Wildlife Conservation Commission. Provides for future repeal of provisions relating to issuance of replacement licenses or permits. Repeals provisions mandating saltwater fishing and lifetime saltwater fishing licenses; snook licenses; certain crawfish permits and stamps; and certain reporting and meeting requirements. Effective July 1, 2002, except as otherwise provided.
- **Ch. 2002-47 (C.S. for H.B. 1487)** Provides an exemption from public records requirements for certain telecommunications service provider audit information received by a taxing authority or its agent. Effective April 16, 2002.
- **Ch. 2002-48 (C.S. for H.B. 1511)** Creates or revises provisions relating to the communications services tax; requires a report. Effective April 16, 2002, except as otherwise provided.
- **Ch. 2002-49 (C.S. for H.B. 1661)** Requires school advisory councils to adopt bylaws; prescribes bylaw content. Effective July 1, 2002.
- **Ch. 2002-50 (C.S. for S.B. 148)** Permits homeowners to display one portable, removable United States flag in a respectful manner regardless of any homeowners' association rules or requirements to the contrary. Effective April 18, 2002.
- Ch. 2002-51 (C.S. for S.B. 1002) Requires psychological counseling or completion of an anger management treatment program for persons convicted of specified acts constituting cruelty to animals and including the knowing and intentional torture or torment of an animal; provides penalties; conforms specified provisions. Effective April 18, 2002.

- Ch. 2002-52 (C.S. for S.B. 2014) Revises provisions implementing an additional homestead exemption for persons 65 or older in counties that have adopted such an exemption. Effective January 1, 2003.
- **Ch. 2002-53 (C.S. for H.B. 893)** Creates provisions regulating intrastate moving services for household goods. Effective July 1, 2002.
- **Ch. 2002-54 (H.B. 183)** Removes a provision relating to certain motor vehicle dealer predelivery service charges from a listing of deceptive and unfair trade practices. Effective April 19, 2002, and retroactively operative to October 1, 2001.
- **Ch. 2002-55 (S.B. 716)** Revises provisions relating to domestic violence; defines "dating violence" and provides penalties for violation of injunction against such violence; repeals provisions relating to the Prevention of Domestic and Sexual Violence Program. Effective January 1, 2003, except as otherwise provided.
- Ch. 2002-56 (C.S. for C.S. for S.B. 1974) Creates or revises provisions relating to crime victims. Effective July 1, 2002.
- **Ch. 2002-57 (C.S. for S.B. 2262)** Creates the Florida Fair Lending Act; prohibits specified loan terms; prescribes disclosures; provides for purchaser liability; establishes procedures to cure default; and provides for administration and enforcement. Effective October 2, 2002.
- **Ch. 2002-58 (H.B. 841)** Creates or revises provisions relating to sexual predators and sexual offenders. Effective July 1, 2002.
- **Ch. 2002-59 (H.B. 949)** Revises provisions relating to notice of anticipated release of certain sexually violent offenders and relating to segregation of certain detainees. Effective July 1, 2002.
- **Ch. 2002-60 (H.B. 219)** Revises provisions relating to open house parties. Effective July 1, 2002.
- **Ch. 2002-61 (H.B. 287)** Revises and readopts exemptions from public records and public meeting requirements for certain information generated by and certain meetings of the Florida Violent Crime and Drug Control Council. Effective October 1, 2002.

- Ch. 2002-62 (C.S. for H.B. 395) Includes certain equipment, accounting software, and services under deferred payment commodity contracts that replace state accounting and cash management systems. Effective April 22, 2002.
- Ch. 2002-63 (H.B. 523) Permits certain community alliances to include specified state attorney and public defender personnel. Effective April 22, 2002.
- **Ch. 2002-64 (H.B. 543)** Provides an exemption from public records requirements for social security and financial account numbers contained in certain reports held by the Department of Banking and Finance. Provides for future review and repeal. Effective April 22, 2002.
- **Ch. 2002-65 (C.S. for H.B. 549)** Enacts the Uniform Child Custody Jurisdiction and Enforcement Act; repeals the former Uniform Child Custody Jurisdiction Act; revises provisions relating to child custody. Effective October 1, 2002.
- **Ch. 2002-66 (C.S. for H.B. 683)** Revises provisions relating to firefighter and police pensions. Effective October 1, 2002.
- Ch. 2002-67 (C.S. for H.B. 735) Provides an exemption from public records requirements for specified materials depicting the internal layout and structural elements of certain agency owned or operated structures. Effective April 22, 2002.
- **Ch. 2002-68 (C.S. for H.B. 777)** Provides exemptions from public records requirements for specified information held by the Office of Tourism, Trade, and Economic Development; Enterprise Florida, Inc.; or certain county or municipal governmental entities and their employees or agents; provides exceptions; provides for future review and repeal. Effective April 22, 2002.
- **Ch. 2002-69 (C.S. for C.S. for H.B. 817)** Creates the Infant Screening Programs Task Force. Effective April 22, 2002.
- **Ch. 2002-70 (H.B. 861)** Revises certain state attorney reporting requirements; repeals provisions requiring an annual report by the Florida Prosecuting Attorneys Association and annual reporting of the number and disposition of certain complaints. Effective July 1, 2002.
- Ch. 2002-71 (C.S. for H.B. 1431) Revises provisions relating to enforcement of warranties on recreational vehicles; postpones termination of a mediation and arbitration pilot program. Effective July 1, 2002.

- **Ch. 2002-72 (H.B. 1439)** Revises provisions relating to the interception of communications. Effective April 22, 2002.
- **Ch. 2002-73 (H.B. 1575)** Creates the Florida Retirement System Contributions Clearing Trust Fund; provides for sources of moneys and purposes; provides for exemption from the general revenue service charges. Effective April 22, 2002.
- **Ch. 2002-74 (C.S. for S.B. 188)** Provides that a person who causes the death of a law enforcement officer, firefighter, emergency medical technician, or paramedic through culpable negligence in certain circumstances commits aggravated manslaughter. Effective July 1, 2002.
- **Ch. 2002-75 (C.S. for S.B. 408)** Provides for designation of certain persons as law enforcement officers and affords such persons specified powers and duties; revises reporting procedures regarding using force on certain inmates or offenders. Effective April 23, 2002.
- **Ch. 2002-76 (C.S. for S.B. 434)** Revises requirements for lists of names submitted by the Department of Highway Safety and Motor Vehicles to clerks of court for the creation of jury lists; requires that applications for driver licenses and identification cards list the county of residence. Effective October 1, 2002.
- **Ch. 2002-77 (S.B. 528)** Prescribes service procedure for certain motions for sanctions in legal proceedings. Effective July 1, 2002.
- **Ch. 2002-78 (S.B. 612)** Adds carisoprodol to Schedule IV of the controlled substances list; reenacts provisions to incorporate the change. Effective July 1, 2002.
- **Ch. 2002-79 (C.S. for S.B. 622)** Prohibits the use of public or commercial transportation or conveyance to commit or facilitate commission of a felony; provides penalties. Effective July 1, 2002.
- **Ch. 2002-80 (S.B. 626)** Prohibits pointing a laser lighting device at a law enforcement officer in certain circumstances. Effective October 1, 2002.
- Ch. 2002-81 (C.S. for C.S. for S.B. 640) Creates or revises provisions relating to criminal offenses involving health care practitioners. Effective July 1, 2002.
- **Ch. 2002-82 (C.S. for S.B. 720)** Creates or revises provisions relating to probate and trusts. Effective April 23, 2002, except as otherwise provided.

- **Ch. 2002-83 (C.S. for S.B. 1772)** Creates a civil cause of action for the knowing and willful damage or destruction of an agricultural product or production system. Effective October 1, 2002.
- **Ch. 2002-84 (C.S. for S.B. 1994)** Exempts certain limited insurance licensee applicants and limited licensees for communications equipment property insurance or communications equipment inland marine insurance from specified requirements. Effective July 1, 2002.
- **Ch. 2002-85 (S.B. 2094)** Requires retesting of certain food products administratively determined to be misbranded. Effective July 1, 2002.
- **Ch. 2002-86 (C.S. for S.B. 2102)** Revises provisions relating to motor vehicle service agreements; revises financial requirements for service warranty associations. Effective April 23, 2002.
- **Ch. 2002-87 (C.S. for S.B. 2252)** Revises provisions relating to timeshares, including issues of promotional prizes, managing entity powers and responsibilities, and certain assessments. Effective April 23, 2002.

- **Ch. 2002-208 (H.B. 1393)** Reenacts specified provisions of chapter 99-188, *Laws of Florida*, relating to sentencing for assault or battery of a person 65 years of age or older. Effective April 29, 2002, to be applied retroactively to July 1, 1999.
- **Ch. 2002-209 (H.B. 1395)** Reenacts specified provisions of chapter 99-188, *Laws of Florida*, relating to sentencing for assault or battery of law enforcement officers; firefighters; emergency medical care providers; and other specified officers, employees, or agents. Effective April 29, 2002, and retroactively operative to July 1, 1999.
- **Ch. 2002-210 (H.B. 1397)** Reenacts specified provisions of chapter 99-188, *Laws of Florida*, relating to sentencing for three-time violent felony offenders. Effective April 29, 2002, to be applied retroactively to July 1, 1999.
- **Ch. 2002-211 (H.B. 1399)** Reenacts specified provisions of chapter 99-188, *Laws of Florida*, relating to sentencing of prison releasee reoffenders and repeat sexual batterers. Effective April 29, 2002, to be applied retroactively to July 1, 1999.

- **Ch. 2002-397 (H.B. 53-E)** Revises provisions relating to the operations of the Department of Children and Family Services; provides for the sale of specified hospital properties and disposition of the proceeds. Effective July 1, 2002.
- **Ch. 2002-398 (H.B. 55-E)** Creates the Workers' Compensation Administration Trust Fund within the Department of Education. Effective July 1, 2002.

- **Ch. 2002-399 (H.B. 57-E)** Creates the Workers' Compensation Administration Trust Fund within the Department of Business and Professional Regulation. Effective July 1, 2002.
- **Ch. 2002-400 (H.B. 59-E)** Creates, revises, or re-enacts provisions relating to health care; repeals provisions relating to imposition of specified interest penalties and the Standardized Credentials Verification Program. Effective June 7, 2002, except as otherwise provided.
- **Ch. 2002-401 (H.B. 67-E)** Revises provisions relating to liability of and waiver of sovereign immunity of state university boards of trustees; defines specified terms as they relate to the Florida Birth-Related Neurological Injury Compensation Plan and revises compensation awards under the plan. Effective January 7, 2003, except as otherwise provided.
- **Ch. 2002-402 (H.B. 29-E)** Provides implementing and administering provisions for the General Appropriations Act for fiscal year 2002-2003. Effective July 1, 2002, except as otherwise provided.
- **Ch. 2002-403 (S.B. 6-E)** Creates the Dale Hickam Excellent Teaching Program to provide funding for certain monetary incentives and bonuses; creates the Dale Hickam Excellent Teaching Program Trust Fund; repeals specified provisions. Effective June 12, 2002.
- **Ch. 2002-404 (H.B. 3-E)** Creates and revises provisions to conform to the cabinet reorganization amendment to the Florida Constitution creating the office of Chief Financial Officer and eliminating the offices of Commissioner of Insurance and State Comptroller; conforms provisions; provides for further conforming legislation; revises the Certified Capital Company Act; enacts the Florida Firefighters Occupational Safety and Health Act. Effective June 12, 2002, except as otherwise provided.
